- For routine cleaning it is recommended to vacuum the carpet weekly, not using the carpet cleaner.
- Immediately clean stains by dabbing with water and neutral soap.
- All sizes can be washed with water, with flat drying, outdoors.
- Professional cleaning at specialized centers is recommended.
- Keep the carpet away from chlorine and salt water.
- During the winter season it is recommended to store the rolled-up carpet in a dry place.
- These rugs are tested for continuous use as outdoor rugs for 350 hours.
